**Subject:** Disclosure of litigation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI Listing Regulations, we wish to inform you that M/s. Piccadily Agro Industries Limited filed a commercial suit bearing Commercial Suit No. 8 of 2025 before the District Court, Karnal against the Company *inter alia* seeking to restrain the Company from using its trademarks “The Spirit of Kashmir Indian Natural Vodka” and “The Spirit of Kashmir Indian Saffron Vodka.”

In the said matter, the Learned District Court, Karnal, vide its order dated September 23, 2025, temporarily restrained the Company from using the mark “Kashmyr”, whether in isolation or in conjunction with any prefix or suffix, till the disposal of the said suit.

Aggrieved by the above order, the Company preferred an appeal before the Hon’ble Punjab and Haryana High Court at Chandigarh, registered as FAO (COM) No. 17 of 2025. The Hon’ble High Court, after hearing the parties, has vide its order dated October 9, 2025, directed that the effect and operation of the order dated September 23, 2025, passed by the Learned District Court, Karnal, shall be kept in abeyance till the next date of hearing.

The brief details required under Regulation 30 is enclosed herewith.

The matter is presently sub judice before the Hon’ble High Court, and we shall keep the Stock Exchanges duly informed of any further material developments in this regard, in compliance with the applicable provisions of the Listing Regulations.

Brief Details of Dispute Litigation	<p>Radico Khaitan Limited ("Radico") is the applicant of the trademarks "The Spirit of Kashmir Indian Saffron Vodka" and "The Spirit of Kashmir Indian Natural Vodka." The Company launched its luxury vodka and made its first sale on May 21, 2025, in the State of Uttar Pradesh after obtaining all requisite statutory approvals.</p> <p>Subsequent to Radico's launch and first sale, Piccadily Agro Industries Limited ("Piccadily") announced its own vodka product under the unregistered mark "Cashmir Vodka" on May 23, 2025, and effected its first sale on May 26, 2025.</p> <p>Despite its later use and absence of prior commercial exploitation of its registered mark "Cashmere" (under rectification), Piccadily instituted a commercial suit bearing Commercial Suit No. 8 of 2025 before the District Court, Karnal, seeking an injunction to restrain Radico from using its applied trademarks, alleging deceptive similarity with its "Cashmere" mark—which has not been used by Piccadily for any of its products to date.</p> <p>The Learned District Court, Karnal, vide its order dated September 23, 2025, granted an interim injunction temporarily restraining Radico from using the mark "Kashmyr" whether in isolation or in conjunction with any prefix or suffix, till the disposal of the said suit.</p> <p>Aggrieved by the said interim order, Radico preferred an appeal before the Hon'ble Punjab and Haryana High Court, registered as FAO (COM) No. 17 of 2025. The Hon'ble High Court, vide its order dated October 9, 2025, has been pleased to keep the operation and effect of the District Court's order dated September 23, 2025, in abeyance till the next date of hearing.</p>
